## **“PROHIBITED & RESTRICTED ARTICLES”**

### **“GOODS REQUIRING HAZARDOUS PACKAGING”**

#### **CHECK BEFORE YOU SHIP – BE AWARE**

##### **PYROTECHNICS, AMMUNITION & WEAPONS:**

The proper United States Government License is required for Legal Exports from the United States to destination abroad. (Firearms, Night Vision, Military Spec items, Blank Ammunition, Knives) Contact your Packair representative as soon as possible to make the necessary arrangements and to determine the necessary documentation required. The approval process may take 30 to 60 days.

##### **HAIR & MAKE UP DEPARTMENTS PRODUCTS:**

Could contain many of the below listed components.

##### **AEROSOL CANS:**

Hairspray, dulling spray, “Dust-off”, spray adhesives, aerosol shaving creams, aerosol, insect repellents, etc.

##### **FLAMMABLE LIQUIDS:**

Oil-based paints, lighter fluid, certain types of perfume, nail polish, etc.  
(Fuel Cells are prohibited!)

##### **SOLVENTS:**

Acetone, thinners, etc.

##### **PETROLEUM BASED PRODUCTS:**

Gasoline or diesel powered engines, generators, compressors, etc.

##### **BATTERIES:**

Wet batteries, Lithium, etc.

##### **COMPRESSED GASES:**

Oxygen, Nitrogen, Acetylene, etc.

IF ANY OF THE ABOVE MENTIONED ITEMS ARE NOT DECLARED, AND ARE DETECTED BY EITHER THE AIRLINE, ANY OTHER CARRIER, OR BY PACKAIR AIRFREIGHT’S INTERNAL RANDOM INSPECTION PROCESS, THE SHIPPER / PRODUCTION COMPANY WILL BE HELD LIABLE FOR CIVIL AND POSSIBLY CRIMINAL PENALTIES AS PREDICATED BY LAW.

MATERIAL SAFETY DATA SHEETS SHOULD BE PROVIDED TO PACKAIR TO DETERMINE THE CORRECT PACKAGING REQUIREMENTS AS PER “IATA” REGULATIONS
